## ONE DAY PERMIT APPLICATION - MAIN STREET BOAT DOCK

Tideline Marine Group is the management operator for the City of Napa's Main Street Boat Dock. An approved permit and certificate of insurance is required for all commercial boating and public day use over three hours. Alcohol cannot be served or consumed without an additional approved permit and will be subject to additional insurance and fees.

### Commercial Day Use

- \$100 Application Fee (annual fee)
- \$1.00 per person and \$1.25 per foot per day (minimum \$35.00)
- Reserve the right to charge daily rate on special event days

### Public Day Use

- First come, first serve for under 3 hours
- \$35 – Three or more hours
- No overnight mooring perr

**GENERAL INFORMATION:**

- Requests for one day commercial or public permits are accepted by submitting a completed, signed permit application to our office by fax, email, US mail, or in person. The office is located at 1681 Tiburon Blvd, Suite B. Tiburon, CA 94920. Office hours are Monday – Friday, 9:00 a.m. to 4:00 p.m. The office is closed Saturdays, Sundays & holidays. Fees can be paid by check or credit card. Please contact us (415)-339-0196 or email us [info@tidelinemarinegroup.com](mailto:info@tidelinemarinegroup.com) for more information.
- Reservations can be made (12) months in advance but no later than (14) calendar days prior to your requested date.
- Liability Insurance is required in the amount of \$1,000,000. Tideline Marine Group and the City of Napa is to be named as additionally insured either on the certificate itself or on an attached endorsement.
- An approved permit will be sent to the applicant when the application is deemed complete, all fees paid in full; and a valid insurance certificate on file. The permit holder should retain a copy of the approved permit with them during their permit times at the boat dock.
- Permits are not transferable. Permit holders must be at least 18 years of age.
- Smoking is prohibited in all City of Napa parks, facilities and boat docks.
- Permit may be revoked at any time the permit application is found to contain false or misleading information or when the permit holder exceeds the stated use and limits of the permit.
- The permit holder shall agree to comply with and accept all policies, rules, and regulations pertaining to the use of City property. Any violation of said policies, rules, and regulations shall be cause for permit revocation and immediate departure from facilities. Authorized individuals or groups shall be solely responsible for the conduct of members or participants in any activity authorized to be held at any City park or facility and agree to limit admission to stated capacity of the area/facility; shall be solely responsible for the use of all properties, equipment, or other resources thereon; and shall agree to be responsible for any damages or mistreatment of any part of the facilities or equipment as indicated on the permit and to pay the cost of any repairs, replacement or damages. Any violations of these polices, rules or regulations may result in future use of facilities being denied.
- The City of Napa reserves the right to close the dock as needed for maintenance, due to inclement weather, when a flood watch has been declared and for general public safety. All permit fees will be refunded if the permit is cancelled due to these circumstances.
- The Main Street Boat Dock is open and from sunrise to sunset daily.
- Motorized boat idling restrictions require that boat motors and generator motors be shut off immediately after mooring.
- A portion of the dock is designated as a passenger loading zone, commercial use and public use. Markings or signage on the boat dock designate these use areas. Depending on your permit, permit holders shall use the appropriate designated area.

- No overnight mooring and no fishing allowed at the boat dock.
- Amplified noise is not allowed on vessels at the boat dock without a special permit by Parks and Recreation Department.
